- 1-Storage condition as well as description of good ,batch NO. and expiry date must be clearly indicated on all packages and relative document.
- 2-- goods must be dispatched/delivered under the same storage conditions that comply with their nature.
- 3-All packages to be stamped or labelled with the following "Sold to RMS" Tender P37-2024-Dry Chemistry"
- 4-Goods should be previously evaluated and approved in DRMS or purchased by "central procurement branch" or by "directorate of defence procurement".

- 10-The supplier or his local agent must furnish RMS a guarantee stamped and legalized by the notary Public to 115% of the goods valid for 1 year after Acceptance of good.
