شروط خاصة

- 1-Dispatched/Delivered good must show Description of goods, expiry date must be clearly indicated on all package and relative documents, Batch No., Storage conditions, manufacturing date, stamped "Sold to RMS", and any other necessary information on the inner and outer packs.
- 2- goods must be dispatched/delivered under the same storage conditions that comply with their nature.
- 3- For items with no expected shelf life :delivered/dispathced goods must show description of goods ,in addition to batch no. ,storage conditions and any other necessary information.
- 4-All packages to be stamped or labelled with the following "Sold to RMS" Tender P36-2024-BLOOD COLLECTION".
- 5- Goods should be previously evaluated and approved in DRMS or purchased by "central procurement branch" or by "directorate of defence procurement".
- 6- all items have FDA approval, CE mark and or TUV certificates.
