- 3- all items must have FDA, TUV, or CE certificate.
- 4- For offers submitted in Jordanian dinars payment will be either by wire transfer or by cheque to be paid after reciving DOCUMENTS FROM MAIN MEDICAL STORES, any other way of payment will not be accepted and the offers will be rejected by the purchase committee.
