### شروط خاصة

- 1-All goods are to be freshly prepared on dispatch/ delivery & should have at least 2/3 of its shelf life upon receipt. Any item carrying less than 2/3 of its shelf upon receipt should be accompanied with a confirmation that you accept to replace any remaining unused quantities at your expenses after the expiry date. Said confirmation is subject to the approval of the director of the Royal Medical Services and will incur a fine, which will be decided later by DRMS according to the loss that this discrepancy with terms of the tender has caused.
- 2-Goods must be dispatched/ delivered under the same storage conditions that comply with their nature; storage conditions must be mentioned clearly on all packages and relative documents.
- 3-Goods must be previously evaluated and approved by DRMS or purchased by "Central procurement Branch" or by "Directorate of Defense procurement" tenders. It is the responsibility of the bidders to submit necessary supportive documents in this case along with their offers.
- 4-DRMS has the right to exchange any size of the awarded items with any other size through the local agent, such exchange should be affected within two weeks after receipt of our written request, any delay will impose penalties as per GHQ/RMS regulations.
- 5-All items should be (FDA and/or CE) approved, except for rings which should be (FDA) approved. A copy of (CE or FDA) certificate is to be submitted, certified by JFDA.
- 6-Holders and sizers should be delivered on (F.O.C) basis for the awarded valves and rings.
- 7-The delivered goods must be stamped, labeled or printed "sold to DRMS" Tender No. P1-2025-3, with irremovable ink. (Except for items which could be exchanged).
- 8-Storage conditions as well as description of goods, lot no., origin of goods, expiry date and manufacturing date must be clearly indicated on all packages (inner and outer) and relative documents. If the manufacturing date is not applicable it must be provided on a separate document.

9-Pricing must include services of sale, shipment, transportation, delivery from port to main medical stores.

10-Custom clearance of goods shall be the responsibility of the Jordan Armed Forces (JAF); however, suppliers shall bear all costs incurred by handling charges and any demurrage or extra expenses incurred by the port's corporation or QAIA (including expenses caused by delay in presenting the necessary shipment documents for either clearing or transporting the goods to the required location mentioned in the final order, delivery note issuing charges, unloading charges, local shipping charges etc.). The supplier is also responsible for providing of all relevant shipping documents, together with the delivery order(s).

11-For offers submitted in Jordanian Dinar, payment will be either by wire transfer or by bank check to be paid after receiving the documents from main medical stores. Any other way of payment will be rejected by the purchasing committee.

12-The supplier or his local agent must furnish RMS with a guarantee stamped and legalized by the notary public equals to 115% of the total value of goods valid for (two years) after acceptance of goods.

13-Prices should be fixed for (2 years) from date of final purchase order.

\*14-Delivery must be in two consignment:

-First consignment (quantity and delivery) will be decided by purchase committee.

-Second consignment for each item is to be within (2 months) from written request from RMS.

15-Bidders must submit their reservation/queries regarding tender specifications and/or special terms within the first half of the tender closing period starting from the tender announcement date, any reservation/queries submitted after the end of this period shall be rejected.

16-The estimated price for any (F.O.C) goods should be stated in the relative sheet.
