- 1 - Delivery in 2 consignment (5-6) month apart , first shipment will be decided by purchasing committee according to the respective minimum guaranteed shelf life upon delivery/dispatch to be provided in the original offers to establish delivery schedule accordingly. The DRMS with this respect reserves the right to reject any item not in compliance with this term and impose the correspondent fines as per GHQ/Military Procurement Laws.
- 2 - Goods having no expected shelf life must be clearly specified otherwise goods should retain at least the MSL.
- 3 - Dispatched/Delivered goods must show Description of Goods, Manufacturing Date &/or Shelf life, Expiry Date, Batch No., Storage conditions, stamped "Sold to RMS", and any other necessary information. Where manufacturing date is not applicable, then shelf life of products offered should be provided
- 4 - Storage conditions as well as Description of Goods, Batch No., and Expiry Date must be clearly indicated on all packages and relative documents.
- 5 - All packages to be stamped or labelled with the following " SOLD TO RMS" TENDER No P37-2022-HEMOGLOBIN
- 6 - Goods with shelf life less than 7 months to be presented in Jordanian Dinars delivered to Princess Eman Research & Laboratory Scientific Center
- 7 - The quality of items should be previously accepted and approved according to DRMS established regulation

- 8 - Pricing must include services of sale , shipment , transportation , and delivery from port to Princess Eman Research & Laboratory Scientific Center
- 9 - Custom clearance of goods shall be the responsibility of the Jordanian armed forces (JAF) however , suppliers shall bear all costs incurred by handling charges and any demurrage charges or extra expenses incurred by the ports corporation or qala (including expenses caused by delay in presenting the necessary documents for either clearing or transporting the goods to the required location mentioned in the final order , delivery note issuing charges , unloading charges , local shipping charges etc). the supplier is also responsible for providing of all relevant shipping documents , together with the delivery order(s).
- 10 - Suppliers should provide 4 f.o.c cuvette readers, in case any reader break down the supplier must replace it a new one f.o.c .
- 11 - The supplier or his local agent must furnish RMS a guarantee stamped and legalized by the notary public to 115% of the goods valid for 1 year after acceptance of each consignment .
- 12 - For offers submitted in jordanian dinars payment will be either by wire transfer or by cheque to be paid after receiving goods , any other way of payment will not be accepted and the offers will be rejected by the purchase committee .
