Training:

- 1. For items where abroad service training courses are required in technical specifications, offers must include a certified service training program for at least 3 working days at a reputable center abroad recognized by the manufacturer for at least two biomedical engineers or biomedical technicians; all costs inclusive, air tickets, boarding, commuting, accommodation (minimum 3star hotel on full board basis) and any extra costs.
