الشروط الخاصة التسلسل

- 1 The delivered goods must be stamped, labled or printed " Sold to DRMS" Tender No. 1-2024-4, with durable ink not easily to remove .
- 2 Goods must be dispatched/delivered under the same storage conditions that comply with their nature. Storage conditions must be clearly indicated on packages and relative documents.
- The delivered /dispatched goods must show description of goods, manufacturing date, expiry date in addition to batch no, and any other necessary information, where manufacturing date is not applicable, then manufacturing date should be provided on relative documents.
- 4 All goods should be (FDA) or (CE) approved.

- Oustom clearance of goods shall be the responsibility of the Jordanian Armed Forces (JAF), however, suppliers shall bear all costs incurred by handling charges and any demurrage charges or extra expenses incurred by the port's corporation or QAIA (including expenses caused by delay in presenting the necessary shipment documents for either clearing or transporting the goods to the required location mentioned in the final order, delivery note issuing charges, unloading charges, local shipping charges, etc.). The supplier is also responsible for providing of all relevant shipping documents, together with the delivery order(s).
- 10 For offers submitted in Jordanian Dinar, payment will be either by wire transfer or by bank check to be paid after receiving the goods. Any other way of payment will be rejected by the purchasing committee.

13 – If the total requested quantities were purchased from a single bidder, the Bidder is requested to provide (2) machines on free of charge bases.

For the F.O.C. machine:

- 1-Two years full warranty for the F.O.C. machines starting date of installation including spare parts & labor. The warranty must be accompanied by a bank guarantee equal to 5% of the total estimated value of the F.O.C machine valid for two year being the warranty period.
- 2-Spare parts must be available for a minimum period of 10 years frm date of installation and commissioning for the F.O.C. machines 3-Equipments to run on single phase 220 v A.C. 50 Hz main electric supply.
- * A comprehensive priced list of spare parts for the F.O. C. machines valid for five years should be submitted upon purchase.
- 4-Adequate on site user training & service training for the F.O.C. machines.
- 5- (A)- two original copies of full operator manual must be provided on free of charge basis with the F.O.C. machines.
- (B)- two original copies of full service manual including spare parts list must be provided on free of charge basis with the F.O.C. machines.
- The estimated price for the (F.O.C) goods should be stated in the relative sheet.

- 15 In addition to the above terms for the FOC machine, supplier should take into consideration the following terms:
 - 1- In case of major equipment failure, the supplier must provide DRMS with a substitute identical device, or repair it within (72) hours. This warranty should last until the end of the contract.
 - 2- If at any time during the warranty period the equipment becomes inoperative due to technical fault the items must then be repaired by the supplier/local agent within period of (14) days from written notification, otherwise the supplier must replace the item with new identical functioning one and will endure a penalty determined by RMS for each day of down time of the system in case the item was replaced by a new one.
