شروط العطاء

شروط خاصة

1- goods must be dispatched/delivered under the same storage conditions that comply with their nature.

2- The supplier or his local agent must furnish RMS a guarantee stamped and legalized by the notary Public to 115% of the goods valid for 1 year after Acceptance of goods.

3- All packages to be stamped or labelled with the following "Sold to RMS" Tender P37 -2025-39" with unremovable ink.

4-a copy of (CE or FDA certificated) is to be submitted and should be certified by JFDA (Jordan food & drug administration).

5- Goods should be previously evaluated and approved in DRMS or purchased by "central procurement branch " or by " directorate of defence procurement ".

6- For offers submitted in Jordanian dinars payment will be either by wire transfer or by cheque to be paid after receiving DOCUMENTS FROM MAIN MEDICAL STORES ,any other way of payment will not be accepted and the offers will be rejected by the purchase committee.

7-Bidders must submit their reservation /queries regarding tender specifications and/or special term within the first half of the tender closing period starting from the tender announcement date . Reservation /queries submitted after the end of this period shall be rejected.

8- Custom clearance of goods shall be the responsibility of the Jordanian Armed Forces (JAF), however, suppliers shall bear all costs incurred by handling charges and any demurrage charges or extra expenses incurred by the port's corporation or QAIA

(including expenses caused by delay in presenting the necessary shipment documents for either clearing or transporting the goods to the required location mentioned in the final order, delivery note issuing charges, unloading charges, local shipping charges, etc.) .The supplier is also responsible for providing of all relevant shipping documents ,together with the delivery order(s).

9-Number of tests per kit/pack to be clearly mentioned where applicable.

10- All goods should retain at least the MSL mentioned per each item. Any item not complying with this term upon receipt should be accompanied with a confirmation that you accept to replace any remaining unused quantities at your expenses after the expiry date. Said confirmation is subject to the approval of the director of the Royal Medical Services and will incur a fine, which will be decided later by DRMS according to the loss that this discrepancy with terms of the tender has caused.

11-Expected shelf life or minimum guaranteed shelf life upon dispatch / delivery must be presented in the original offer.

12- Any goods with no specific shelf life or not carrying an expiry date should be clearly indicated.

13-Dispatched/Delivered good must show Description of goods , expiry date must be clearly indicated on all package and relative documents ,Batch No., Storage conditions, stamped "Sold to RMS" ,and any other necessary information on the inner and outer packs. Where manufacturing date is not applicable then it should be provided on relative documents.

14-Pricing must include services of sale ,shipment,transporation,delivery from port to site .

15- Number of shipments will be decided by purchasing committee according to the respective minimum guaranteed shelf life upon delivery/dispatch to be provided in the original offers to establish delivery schedule accordingly .The DRMS with this respect reserves the right to reject any item not in compliance with this term and impose the correspondent fines.

16- All accessories such as reaction tubes, sample cups, buffers, substrate, and all other requirements for test performance should be included to the number of test in each instrument.

17- Offers must include a full warranty including spare parts and labour for a period of minimum of 24 months from the date of first shipment/consignment for all the existing machine.
