الشروط الخاصة التسلسل

- 1 – Samples of the quoted items must be submitted along with the offers, showing the same serial No./Stock No.as per our tender documents specifications.English and arabic product leaflet should be provided,too.
Extra sample should be provided within one week upon request.
- 2 – a. Goods should retain not less than 66% of its shelf life or 2 years effective duration (Whichever the longest) upon delivery .
b. Shelf life should be clearly indicated for each quoted item.
c. The DRMS with this respect reserve the right to reject any item not in compliance with this term.
- 3 – Goods must be dispatched under the same storage conditions that comply with their nature,storage conditions must be clearly indicated on packages,AWB/BL,all relevant documents as well as on the outer cartoons.
- 4 – Each lot should pass the inspection carried out at the Jordanian Quality Assurance Laboratory in the Jordan Food and Drug Administration (JFDA),all inspection charges will be on local agent expenses,any rejected lot should be returned back to the supplier at his own expense and replacement and/or compensation should be delivered or effected in a period not exceeding 30 days from written notification by the Directorate of the Royal Medical Services.
- 5 – All outer and inner packs to be stamped or labelled with the following "
Sold To DRMS /Tender P62-2024

- 6 - The delivered goods must be labelled with the following on the inner & outer packages : Description of Goods, Manufacturing date , Expiry date, in addition to the Batch No, Storage conditions and any other necessary information, in English and Arabic.
- 7 - a) Items Should be previously evaluated and approved by DRMS and registered at JFDA ,supportive documents should be provided with the offers.
b) under registration or non registered items should be previously evaluated and approved by DRMS, supplied with newly issued free sale certificate (FSC) or CE certificate.Said certificates should be submitted along with the quotations/documents.
- 8 - a)The shipment/delivery of the goods should be in 2 equal consignments (8-9) Months apart.
b)for items with a shelf life two years, shipment to be in 3 equal shipments (5-6) months apart.
-first shipment not to exceed 2 months from the date of final order.
c)The tender committee reserves the right to amend or alter the shipment according to DRMS needs

- 9 – Individual packs should be made from high quality material,unbreakable,leak-proof containers and outer cartoons should be strong,export quality material,able to withstand rough handling during transport and endure piling up upon storage.Packs should be stacked vertically not exceeding 6 cartoons in height,in case of damage during storage leading to any leakage in the containers then the affected containers should be replaced immediatly.The empty spaces in cartoons should be filled with newspaper,wood shavings or other loose material to stop the contents from rattling about and prevent cartoons from being crushed.
- 10 – Prices should be fixed for (24 months) after date of final order.
- 11 – All certificates & requirements needed by (JFDA)should be submitted by your Local agent (directly to JFDA) to fullfill their prerequisites for their marketing approval & to carry out the analysis by their quality control laboratories. DRMS will not be responsible for any cause leading to rejection or delay in testing due to missing of any of the needed requirements.
- 12 – After arrival to Jordan, DRMS is not responsible for any handling Charges for goods (Like charges for issuing delivery note vouchers, unloading charges, local shipping agents charges) and GHQ/RMS are not responsible for any demurrage charges and other charges incurred by the port corporation caused by delay in presenting all necessary shipping documents for clearing the goods.

- 13 - A.DRMS has the right to increase the awarded quantities by 35% after final order notification with the same (prices, terms & conditions) of the contract upon our request and approval of the contractor.
B. DRMS has the right to decrease the awarded quantities by 50% after final order notification upon our request and approval of the contractor.
- 14 - The companies are required to comply with the Specifications of the required items exactly, if there is any deviation from the specification, the word "Alternative" Should be mentioned clearly.

15 - a)For item no (06-50)

- Universal wall holders should be supplied on Free of Charge basis(quantity not less than 50000 universal wall holders)

-Dosing pump to be prefitted as part of each bottle from the manufacturer per each liter

* After award, Local agent will be responsible for the fixation of the wall holders at the hospitals of Royal Medical Services in coordination and cooperation with the Infection Control Department of Royal Medical Services.

b)For item no.(06-70)

Sprayers should be supplied on F.O.C basis (quantity provided is to be per each Gallon of the item

c)For items no.(06-60,06-95)

(10ml-20ml)pumps should be supplied on F.O.C basis (quantity provided is not less than 50% of the no. of the awarded gallons 1 lit or 5 lit)

- Samples of the requested pumps,sprayers,dosing pump and universal wall holders should be submitted along with the offers, all should have an effective valved system.

- The training and education for using all awarded items should be provided by local agent in cooperation with Infection Control department in RMS.

d)For item no (06-951)Local agent is responsible for providing staff,machine and accessories needed for the sanitising procedure whenever needed by the Royal Medical Services on free of charge basis.

- 16 - The DRMS has the right to test the efficacy of any product to assure its validity in any laboratory considered as suitable and convenient for the RMS and all inspection charges will be on local agent expences.

In case the product failed the test RMS has the right to exchange all the awarded quantity or to have a full refund in addition to a penalty that will be decided later by RMS according to the loss that occurred.

- 17 - Due to storage limitations the bidding companies should comply with the delivery term to avoid unnecessary storage or delay penalties.

- 18 - * Early delivery/shipment should only be done by written approval of (DRMS) * Otherwise early delivery/shipment before due time for each consignment will impose on you a penalty .

- In addition to the above mentioned penalty a confirmation to replace any remaining unused quantity after the expiry date (for the early delivered/shipped quantity) should be accompanied either by supplier or the local agent in Jordan.

- 19 - Any delay in shipment/delivery will impose on you a penalty .

- 20 - The tender board has the right to disregard any offer not complying with any of the above mentioned requirements.

21 - Replacement of any item previously accompanied with a confirmation should be affected within (3 months) from the date of the written notification with the same terms and conditions of the award unless otherwise requested by RMS according to their stocks and needs .

-RMS reserves the right to have the compensation either as goods with the above mentioned conditions or as a value according to RMS needs

22 - Expiry date,lot number as well as manufacturing date must be mentioned clearly on the inner as well as the outer packs in addition to related shipping documents.

23 - In Case of recall for any item after delivery for causes regarding safety , efficacy and Quality of the item , replacement and /or compensation by value (according to RMS need) should be delivered or effected in a period not excceding 30 days from the written notification by the Directorate of the Royal Medical Services .

24 - RMS is not responsible for any damage that may occur to goods due to incompilance (of the contractor or his shipping agent) to rules and regulations of Royal Jordanian and /or airport authorities in jordan concerning pre -arrangement for storing goods that need special storage condititons (e.g cool storage).

- 25 - The acceptance of any discrepancy concerning the delay in shipment /delivery for the medication that exceeds 60 days or early shipment /delivery or changing the origin of goods and for any other discrepancy not in compliance with the other terms is subjected to approval of GHQ.
- 26 - Pricing must include services of sale , shipment, delivery from port to site or to main medical stores .
- 27 - Custom clearance of goods shall be the responsibility of the Jordanian Armed Forces (JAF), however, suppliers shall bear all costs incurred by handling charges and any demurrage charges or extra expenses incurred by the port's corporation or QAIA (including expenses caused by delay in presenting the necessary shipment documents for either clearing or transporting the goods to the required location mentioned in the final order, delivery note issuing charges, unloading charges, local shipping charges etc .) the supplier is also responsible for providing of all relevant shipping documents , together with the delivery order(s) .
- 28 - For offers submitted in Jordanian Dinars, payment will be either by wire transfer or by cheque to be paid after receiving goods. Any other way of payment will not be accepted and the offers will be rejected by the purchase committee.
