- 1 - Number of shipments will be decided by purchasing committee according to the respective minimum guaranteed shelf life upon delivery/dispatch to be provided in the original offers to establish delivery schedule accordingly. The DRMS with this respect reserves the right to reject any item not in compliance with this term and impose the correspondent fines .
- 2 - The minimum guaranteed shelf life upon delivery /dispatch to be included with the original offer (Minimum shelf life 4 weeks)
- 3 - Dispatched /Delivered goods must show Description of Goods ,Expiry Date, Batch No., storage conditions, stamped "sold to RMS" and any other neccessary information.
- 4 - storage conditions as well as Descrption of Goods Batch No ., and expiry date must be clearly indicated on all packages and relative documents.
- 5 - All packages to be stamped or labelled with the following "sold to RMS". Tender P37-2023-32-1
- 6 - Goods must be dispatched /delivered under the same storage conditions that comply with their nature.
- 7 - Products derived or containing materials of human origin should be supplied with a certifacte and/ or official document from the manufacturer stating that the products are devoid of blood borne infectious agents : HbsAg , HIV,HCV , etc. Items belonging to this category to be specified in the original offer.

8	- All Items should be delivered in 12 shipments to Princess Iman /King Hussain Medical Center
9	- Pricing must include services of sale, shipment , transportation ,delivery from port to site or Main Medical Stores.
10	- Custom clearance of goods shall be the responsibility of the Jordanian Armed Forces(JAF), however , suppliers shall bear all costs incurred by handling charges and any demurrage charges or extra expenses incurred by the ports corporation or QAIA (including expenses caused by delay in presenting the necessary shipment documents for either clearing or transporting the goods to the required location mentioned in the final order, delivery note issuing charges, unloading charges ,local shipping charges etc.) The supplier is also responsible for providing of all relevant shipping documents, together with the delivery order(s).
11	- For offers submitted in Jordanian dinars payment will be either by wire transfer or by cheque to be paid after receiving goods ,Any other way of payment will not be accepted and the offers will be rejected by the purchase committee.
12	- The quality of items to be accepted and approved by DRMS according to DRMS established regulations.
