1-Number of shipments will be decided by purchasing committee according to the respective minimum guaranteed shelf life upon delivery/dispatch to be provided in the original offers to establish delivery schedule accordingly .The DRMS with this respect reserves the right to reject any item not in compliance with this term and impose the correspondent fines.

2-Dispatched/Delivered good must show Description of goods , expiry date must be clearly indicated on all package and relative documents ,Batch No., Storage conditions, stamped "Sold to RMS" , origin of goods ,and any other necessary information on the inner and outer packs. Where manufacturing date is not applicable then it should be provided on relative documents.


3- goods must be dispatched/delivered under the same storage conditions that comply with their nature.

4-offers to include all kit size configurations from Manufacturer.

5-All packages to be stamped or labelled with the following "Sold to RMS" Tender P37-2025-35"by un removable ink.

6-Any Products derived or containing materials of human origin should be supplied with a certificate and/or official document from the maunfacturer stating that the products are devoid of blood borne infectious agents :HbsAg, HIV, HCV, ect. Items belonging to this category to be specified in the original offer.

7- Goods should be previously evaluated and approved in DRMS or purchased by "central procurement branch " or by " directorate of defence procurement " ,for the previously evaluated & approved items the approve certificate sholud be provided along with the offers and the previous legalized purchases order should be provided along with the offers .



8-Number of tests per kit/pack to be clearly mentioned where applicable.

9-The company must provide us with updated soft ware as a free of charge to include the new nomenclature for analysis and interpretation of HLA results and to train the personnel on using the reagents and the soft ware.

10-All items to be delivered to Princess Iman Research Center-KHMC.

11-The supplier or his local agents must furnish RMS a guarantee stamped and legalized by the notary public to 115% of the goods valid for 1 year after acceptance of goods.

✓ 12-For offers submitted in Jordanian dinars payment will be either by wire transfer or by cheque to be paid after receiving goods , any other way payment will not be accepted and the offers will be rejected by purchase committee.

13-All goods should retain at least the MSL mentioned per each item. Any item not complying with this term upon receipt should be accompanied with a confirmation that you accept to replace any remaining unused quantities at your expenses after the expiry date. Said confirmation is subject to the approval of the director of the Royal Medical Services and will incur a fine, which will be decided later by DRMS according to the loss that this discrepancy with terms of the tender has caused.

14-Acopy of (CE or FDA certificated)is to be submitted and should be certificated by JFDA(Jordan food & drug administration).

15- Each company must provide DRMS with F.O.C items which mentioned in Annex (A) in a sufficient quantity.

16-Each company must provide the following maintenance and maintenance service kit as F.O.C:

- a) A monthly visit for preventive maintenance and general check for the instruments.
- b) Replacement of - 12 month preventive maintenance service kit - for each instruments.

- c) On site emergency breakdown service, including laser alignment if needed.
d) Calibration & Verification kit performance are included once needed for all types of instruments (Luminex xMAP and Luminex FLEXMAP 3D).

17- A) a Full warranty including spare parts and labour for a period of 12 months from the delivery of the first consignment, the warranty must be accompanied by a bank guarantee equal 5% of the value for the equipments mentioned in Annex (B).

B) If any time during the warranty period the item become inoperative due to technical fault the item must then be repaired by the supplier/ local agent within a period of fourteen days from written notification, and if the failure continues more than fourteen working days the broken device will be replaced by another identical functioning device until repairing the broken one ,the replacing device should not be withdrawn until the old device is returned and is in full operation.

18-Bidders must submit their reservation /queries regarding tender specifications and/or special term within the first half of the tender closing period starting from the tender announcement date . Reservation /queries submitted after the end of this period shall be rejected.
