## شروط خاص\_\_\_ة

- 1- Delivery in 2 consigiment (5-6) month apart , first shipment will be decided by purchasing committee according to the respective minimum guaranteed shelf life upon deliverey/dispatch to be provided in the original offers to establish delivery schedule accordingly. The DRMS with this respect reserves the right to reject any item not in compliance with this term and impose the correspondent fines .
- 2-Goods having no expected shelf life must be clearly specified otherwise goods should retain at least the MSL .
- 3-Dispatched/Delivered good must show Description of goods, expiry date must be clearly indicated on all package and relative documents, Batch No., Storage conditions, stamped "Sold to RMS", and any other necessary information on the inner and outer packs. Where manufacturing date is not applicable then it should be provided on relative documents.
- 4-Storage conditions as well as description of goods, batch no., and expiry date must be clearly indicated on all packages and relative documents.
- 5-All packages to be stamped or labelled with the following "Sold to RMS" Tender P37-2024-HEMOGLOBIN".
- 6- Goods should be previously evaluated and approved in DRMS or purchased by "central procurement branch" or by "directorate of defence procurement".
- 7-Pricing must include services of sale ,shipment,transporation,delivery from port to site to Princess Eman Research & Lboratory Scientific Center.
