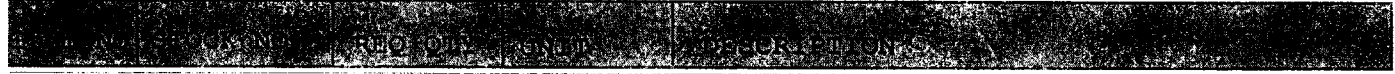

الشروط الخاصة التسلسل

- 1 - GOODS MUST BE DISPATCHED/DELIVERED UNDER THE SAME STORAGE CONDITIONS THAT COMPLY WITH THEIR NATURE.
- 2 - STORAGE CONDITIONS MUST BE CLEARLY INDICATED ON ALL PACKAGES AND RELATIVE DOCUMENTS.
- 3 - THE QUALITY OF ITEMS SHOULD BE ACCORDING TO ACCEPTED INTERNATIONAL STANDARDS I.E (FDA, CE, U.S.PHARMACOPOEIA, EUROPEAN PHARMACOPOEIA, B.P, T.U.V. OR EQ. STANDARD CERTIFICATES) SHOULD BE ACCOMPANIED WITH THE OFFERS.
- 4 - THE DELIVERED GOODS MUST BE STAMPED,PRINTED OR LABELLED:- "SOLD TO DRMS" WITH DURABLE INK
- 5 - ALL PARCELS, PACKAGES AND RILATIVE DOCUMENTSTO BE MARKEE DRMS TENDER NO. P15-2021-10 GHQ JORDAN ARMED FORCES
- 6 - DELIVERY PERIOD WILL BE TAKEN INTO CONSIDERATION.
(Prompt delivery will be given the Priority)
- 7 - SAMPLES OF THE QUOTED ITEM MUST BE SUBMITTED ALONG WITH THE OFFERS, FOR EVALUATION PURPOSE, PURCHASE AND RECEIPT PURPOSES.
RMS WITH THIS RESPECT RESERVES THE RIGHT TO REJECT OFFERS NOT IN COMPLIANCE WITH THIS TERM.
- 8 - THE SUPPLIER OR HIS LOCAL AGENT MUST FURNISH THE RMS WITH AGUARANTEE STAMPED AND LEGALIZED BY THE NOTARY PUBLIC EQUALS TO 115% OF THE TOTAL VALUE OF THE GOODS VALID FOR (1 YEAR) AFTER ACCEPTANCE OF GOODS.

التسلسل الشروط الخاصة

- 9 DRMS HAS THE RIGHT TO INCREASE THE AWARDED QUANTITIES BY A PERCENTAGE NOT EXCEEDING 30% AFTER FINAL ORDER NOTIFICATION WITH THE SAME PRICES , TERMS & CONDITIONS
- 10 – FOR OFFERS SUBMITTED IN JORDANIAN DINARS PAYMENT WILL BE EITHER BY WIRE TRANSFER OR BY CHEQUE TO BE PAID AFTER RECEIVING GOODS.
ANY OTHER WAY OF PAYMENT WILL BE REJECTED.
- 11 – OFFERS SHOULD BE SUBMITTED IN JORDANIAN DINNARS DELIVERED TO MAIN MEDICAL STORES.
- 12 – ITEMS MUST SHOW DESCRIPTION OF GOODS, SIZE, MANUFACTURING DATE, EXPIRY DATE, BATCH NO., STORAGE CONDITIONS AND SHOULD RETAIN AT LEAST 2/3 OF THEIR SHELF LIFE UPON RECEIPT.
- 13 – WHERE APPLICABLE,THE ACCEPTANCE OF THE GOODS IS SUBJECTED TO THE APPROVAL OF THE QUALITY ASSURANCE LABORATORY OF THE JFDA.
A. ALL INSPECTION CHARGES WILL BE ON LOCAL AGENT EXPENSES.
B. ANY REJECTED LOT SHOULD BE RETURNED BACK TO THE SUPPLIER AT HIS OWN EXPANSES AND / OR COMPENSATION SHOULD BE DELIVERED OR EFFECTED IN A PERIOD NOT EXCEEDING (30) DAYS FROM THE WRITTEN NOTIFICATION BY THE DIRECTORATE OF THE ROYAL MEDICAL SERVICES.
- 14 – Pricing must include services of sale, shipment, transportation, delivery from port to main medical stores.
